PROVIDED BY LTR LIFTS & ESCALATORS

- Liase with Police and Local Authorities regarding transportation and access to site.
- Cranage to off load at site (subject of P.C. sum included in standard price)
- Labour for off loading and manoeuvre of Passenger Conveyors to the finally installed position.
- Lifting Equipment (chain blocks and slings only).

PROVIDED BY OTHERS

1. Calculations with regard to the building.
2. Builder's work such as forming the well, pit and/ or machine room to interface with the Passenger Conveyor dimensions as detailed on LTR General Arrangement Drawings.
3. Cutting away and making good.
4. Site painting after installation other than bright parts or factory finished surfaces)
5. Treatment of Passenger Conveyor area to inhibit the formation of dust.
6. Suitable lifting and pulling points to suit LTR's requirements.
7. Levels for sizing of Passenger Conveyor.
8. Any reinforcement necessary for load bearing together with properly located supports of adequate strength for truss at upper and lower landings, and intermediate supports.
9. Any necessary drainage, tanking, lining or reinforcing of Passenger Conveyor area.
10. Guarding of openings and other measures necessary to ensure the safety and convenience of the occupants and other personnel within the building.
11. Scaffolding, load bearing platforms, planks, ladders and temporary screening to LTR requirements.
12. Storage of materials, tools and clothing in a suitably locked dry, heated and illuminated storage space protected from theft and damage.
13. Suitable temporary and permanent power supplies for tools and equipment, shutters and the operation of the Passenger Conveyors in accordance with an agreed programme.
14. Mess rooms, sanitary accommodation and welfare facilities.
15. A roadway or equal immediately adjacent to the building entrance where off-loading will take place. The reinforcement of paving and floors, making suitable access.
16. Provision of ramping, protection and all necessary access space for unloading, hoisting or lowering of the Passenger Conveyors, in or outside the building or within the Passenger Conveyor well and for the handling to its final position.
17. Suitable floor openings, properly framed and finished in accordance with LTR's drawings, all permanent enclosures, shutters, railings, sprinklers and smoke baffles for the Passenger Conveyor area that may be required.
18. Proper covering of the Passenger Conveyor for protection against damage and contamination until acceptance. Cleaning down, renewal or replacement of equipment damaged by dust produced from other contractor's processes such as dry grinding of mosaic and other builders work.
19. As may be necessary for Passenger Conveyors installed in the open, working scaffolding of proper height and temporary screening around the Passenger Conveyor, consisting of a working weatherproof cover with heating if necessary, for the protection of the workmen concerned. The provision of drains connected to the lower outlet end of drip trays capable of dealing with the most abnormal rainfall.
20. Extra costs due to surveyor's fees or special requirements of government departments, local authorities, insurance companies consultants other bodies or officials.
21. Provision of safe and adequate access to the site and Passenger Conveyor area to the satisfaction of the Health & Safety at Work Act.
22. Provision for taking on any of the roles specified in the C.D.M. Regulations other than that of 'Contractor'.
